1. CALL TO ORDER

3. PRINCIPAL UPDATE - Joan Wieser

- Excited to get back to school, wants to acknowledge that plans are not ideal but made with the best intentions.
- Specials: will send info tomorrow to clarify, but due to teacher requirements for lunch and planning times (45 min each) we are not able to have specials. If we had specials it would be virtual (kids at desks). Don't have manpower to provide teachers with health/safety guardrails. Specials will be offered at the end of day (after dismissal) and asynchronous.
 - Hoping in January to bring back specials (quarter 3).
 - Specials teachers are taking on different roles Conklin & Miller teaching 1st grade remote
 - Para: 1 para will be remote, others will support classrooms.
- Arrival/dismissal procedures not yet finalized.
- Joan has maxed out her budget to meet in person and remote learners, it is good that we have the specials teachers to help support teachers.
- District took Joan's carry forward (\$60k).
- Cory will get funded fully regardless of final count.
- Kara Wilson resigned, but she can now re-hire (doesn't have to repay district).
- Oct 5-6: breakfast/lunch for teachers as they set up classrooms (Naurin & Kristine will head up)
- Safety needs:
 - Tent for outdoor learning
 - Joan is encouraging teachers to take kids outside
 - No formal schedule for tent usage

- DPS has signed off on tents from safety purpose, no heaters allowed
- We will ask for a bid for 1 tent to hold 1 cohort
- Masks they have enough. Kelly Hanson ordering 150 kid masks.
- Lanyards will be a need for mask breaks
- Mark Smiley to provide a pallet of hand sanitizer
